

## MEMORANDUM OF UNDERSTANDING BETWEEN TOTTENHAM HOTSPUR FOOTBALL CLUB AND PROUD LILYWHITES.

### PURPOSE

1. This Memorandum of Understanding (“**MOU**”) is intended to record the key principles which Tottenham Hotspur Football & Athletic Co Ltd (company no. 00057186) (the “**Club**”) and “**Proud Lilywhites**” (the Club’s official LGBTQ+ supporters’ association) intend to underpin their future relationship.
2. Each of the Club and Proud Lilywhites acknowledge and agree that this MOU is not a legally binding document and does not impose legal obligations upon either party.

### COMMUNICATION

3. For the period that the Club has a Fan Advisory Board in place, the Club will continue to build on the long-standing association with Proud Lilywhites and the co-operation that has always existed between the two (2) parties. The Club will continue to meet regularly with Proud Lilywhites to discuss specific issues affecting LGBTQ+ fans. These meetings will include ongoing interaction and dialogue between the Head of Supporter Engagement, other Club staff and representatives of Proud Lilywhites.
4. Proud Lilywhites Co-Chairs will meet the Club’s Executive Director and Head of Supporter Engagement once a year to discuss the key areas of Proud Lilywhites’ remit, strategy and aims for the year and how the Club can support them. Any minutes issued to Proud Lilywhites’ members must be approved in writing by the Club prior to publication.

### REMIT

5. The following subject matters will be deemed to fall within the Proud Lilywhites’ remit for the purposes of this MOU:
  - The experience of Proud Lilywhites members and other LGBTQ+ fans
  - Campaigns supporting and advocating for LGBTQ+ fans and tackling discrimination
  - Broader initiatives relating to equality, diversity and inclusion

### REVIEW

6. Unless otherwise agreed in writing between the parties, the Club and Proud Lilywhites shall meet once each year to review the terms of this MOU to ensure it is operating effectively.

### TERMINATION




